Job Details:

Job Title: Maintenance Supervisor

Reports to: Directors

Leadership of: Maintenance Operative

Job Purpose:

- To carry out day to day maintenance, inspect equipment and basic repairs.
- To supervise a maintenance operative
- To provide out of hours on-call cover for building security

Summary of Responsibilities

Leadership:

- To manage the Maintenance team, including delegation of work and checking quality of work is maintained.
- To ensure all requests for maintenance of the nurseries are actioned in a timely manner
- To ensure Little Elms remain compliant with Health and Safety regulations

Cleaning:

- To clean driveways, outdoor walkways and areas of buildings
- To grit outdoor areas (when necessary)

Garden:

- To clear debris (such as leaves from external areas of buildings)
- To cut the grass and keep neat and tidy

Inspections:

• To conduct routine inspections of premises and equipment

Electrical

- PAT Testing
- Regular emergency lighting testing

Repairs:

- Handling basic repairs
- Oversee contractors where professional repairs are necessary
- Diagnosing repair needs and working with external contractors to get quotes etc

General Maintenance

- To carry out general maintenance tasks as directed by each Nursery Manager
- To construct newly purchased furniture and/or equipment as required

Out of Hours Building Security

- To provide on-call cover for emergencies / security breaches that may occur out of nursery opening hours. This will be agreed on a shared rota basis between Maintenance team members.
- To respond to out of hours calls from the alarm company
- To assess any security breaches at any of our nursery buildings, by checking CCTV when the alarm is activated.



- To call the emergency services (police) if an actual security breach is identified
- To attend nursery buildings out of hours to deactivate the alarm, if safe to do so.

Assignment and Review of Work

- A good level of autonomy is required in this role
- Requests for work will come from the Nursery Team, Senior Management or Owners

Decision Making

- High level of decision making relating to health and safety aspects across the group
- No financial responsibility

6. Selection Criteria

Knowledge, Skills & Experience

- Previous experience in maintenance is essential
- Experience of prioritising and assessing risk and workload
- Skilled use in various hand and power tools
- Be able to read plans and repair manuals
- Full and clean diving license is essential and to meet insurance requirements for the company vehicle, the individual must have had a licence for a minimum of 2 years and be aged 25 or over.
- Experience of electronical testing devices
- Trained to carry out Portable Appliance Testing
- Knowledge and demonstrable understanding of health and safety requirement relevant to nurseries

Person Specification

- Clear and satisfactory safer recruitment checks (including a clear enhanced DBS check)
- Good communication skills are essential, both verbal and written.
- Strong organisational and follow up skills are essential
- The ability to manage own workload and work alone, with limited supervision
- High attention to detail
- Professionally presented
- Ability to cope with change in a fast-paced environment is essential
- Ability to problem solve and use own initiative
- Ability to work under pressure and with ever changing priorities is essential
- Ability to use initiative and problem solve with little supervision
- Ability to lead by example
- Ability to delegate work and supervise others to achieve outcomes
